- vii) to execute conveyances, transfers of coverment securities, reconveyances, mortgages, leases, bonds and agreements in respect of property, moveable or immoveable belonging to the Trust or to be acquired for the purposes of the Trust;
- viii) to appoint in order to execute any instrument or transact any business of the Trust, any person as attorney of the Trust with such powers as they may deem fit;

    Department -60-
  - 7) Two eminent educationists
    to be numinsted by the Co-cpted Member
    Trust
  - 8) One member to be nominated by the Punjab Defence and Security Relief Fund Committee
  - 9) Member Secretary of the Ex-Officio Member Trust
  - (b) The Chief Minister of the Punjah shall be the Ex-Officio Chairman of the Hoard and the Principal and Director of Sri Dagmesh Academy shall be the ex-Officio Member Secretary of the Board.
- (c) The term of the Board shall be three years.
- (d) The seat of a numinated Member of the Board shall become vacant if he/she dies, resigns, becomes of unsound mind, is declared insolvent, is convicted of criminal offence, involving moral turpitude, ceases to be a member of the Committee/Trust, accepts any paid job or office of profit in the Academy or enters into any contract or relationship with the Academy thereby his interest as Member conflicts with his duty as such or is removed by the Trust from the Membership of the Board.

A member other than an ex-officio member may region his office by a letter addressed to the Chairman, and such resignation shall take effect as soon as it had been delivered to the latter.

### FILLING UP VACANCIES

- (a) Any vacancy in the Board shall be filled in the same manner as is provided in regulation No 2.
- (b) No act done, or proceedings taken by the Board shall be invalid merely on the ground of any vacancy or defect in the constitution of the Board or of any defect or irregularity in the nomination of any person acting as member thereof or of any defect or irregularity in such act or proceedings not effecting the merits of the case.

#### POWER OF THE BOARD

The Board shall have all powers which may be necessary or expedient for the achievement of the objects of the Trust. These powers shall include power to create any post for carrying out the purposes of the Trust and to employ any officer and servant including the Head of the Educational Institution and other teaching staff, to fix their grades of pay, emoluments and other terms and conditions of service, to suspend, remove, dismiss or otherwise punish any officer or servant so appointed and to abolish any post when in the opinion of the Trust it is no more required.

# POWERS AND DUTIES OF THE CHAIRMAN OF THE BOARD

- The Chairman shall have power to convene meetings of the Board at any time when he considers it necossary.
- (b) In an emergency, which, in the opinion of the Chairman requires that immediate action should be taken, the Chairman shall take such action as he deems necessary but shall report his action to the Board at its next meeting.
- (c) The Chairman shall exercise such other powers as may be delegated by the Woards
- In the absence of the Chairman, at any meeting of (d) the Board, the Members present shall elect one from amongst themselves to proside at the meeting.

## POWERS AND FUNCTIONS OF THE MEMBER SECRETARIES

- The Monder Secretary of the Trust shall be the Chief Moministrative Officer of the Trust and be responsible for the setting up of the entire Campus and carrying out all the directives of the Trust.
- The Member Secretary of the Board of Governors shall be responsible for the Academic Wing including its administration and shall deal with the Board of Governors for the said purpose.

(c) The Chairman, if present, shall preside over the meetings of the Board and in his absence, the members present shall elect one from amongst themselves to preside. - SUITS BY OR AGAINST THE TRUST All suits, complaints and applications by the Trust in any court or Office whatsoever shall be instituted or filed in the name of the Trust under the signatures of the Member Secretary of the Trust/Board of Governors or if for any cause they are unable to do so on account of physical absence or otherwise, any other member of the Trust/Governing Body, may do so, if authorised by a resolution of the Trust duly passed at a meeting convened for the purpose. FUNDS OF THE TRUST All funds of the Trust shall be invested in a Bank or Banks or in financially sound companies offering best rate of interest. The Member Secretary of the Trust alongwith another Trustee or member of the Building Committee to be nominated for this purpose shall be entitled to and authorised to deal with the same. For the purposes of dealing with Bank Or Banks or with Govt in regard to funds and investments of the Trust, they shall be and are bereby authorised to sign, endorse, negotiate and otherwise deal with all such accounts, funds or investments.
